Reports and related Action Items

- Bishop's Report:
 - o How we partner with our companion diocese (El Salvador currently) and others in Iarca is a continuous question?
 - o Excited to see that St. Matthew's, Liverpool has connected with St. Matthias parish in Guatemala.
 - o Church Planting: I will be thinking about this on Sabbatical. How might God be planning for us to build new ministries - not building buildings, but ministries. I am interested in mentorship, and what changes people's chance to succeed... when they are engaging with people who are not in their same circles. Building relationships with others.
- [Property Report](#) - Henry Wakefield
 - o Charles Moore and Henry Wakefield went to Grace, Willowdale. Visited the tenant, got boxes for archives, etc.
 - o Up to 4 graves on church property themselves.

- o Tenant asked if we would still reimburse him when he makes updates to the house? We're not sure what the original lease agreement terms were. We will find the original lease and see if that allows for that.
- o Two surveys Pierrepont Manor and Brownsville have not been completed yet
- o Trinity, Elmira buyer is submitting bills for repairs to try and lower cost of purchasing.
- o Schedule for organ removal at Chadwicks not set, but will be down the road.

 - Cathy Wouldn't recommend taking action on surplus until Finance cmte. has taken a look at it.

 - o Molly will get the boxes from Grace, Mexico to archives.
 - o Update from Canon Carrie about Constableville, looking to close. Jane Gendron and Molly Payne-Hardin will work with Peter Hayes and Gilda Krywosa in Constableville when they are ready to proceed.
